To the Parties:

On July 7, 2017, Kevin Spencer and Mark Lagasse d/b/a Lagaspence Realty, LLC filed a Motion to Compel Response to Data Request (Motion) in the above referenced matter, to which Eversource objected on July 17, 2017.

New Hampshire Code Admin. Rule Puc 203.09(i)(4) requires a party filing a motion to compel to certify that the party made a good-faith effort to informally resolve the discovery dispute. The Lagaspence Motion does not include such certification, and Eversource confirmed in its objection that the movant made no effort to resolve the issue informally.

The Commission has denied without prejudice the Motion for failing to comply with the Commission's rules.
